A drilling rig for groundwater monitoring boreholes was present on the North boundary of site and was drilling outside of the area contained by an HDPE liner. Cuttings and water from groundwater borehole drilling were stored in a skip within the contained area. Some run off of water and fines from the skip had entered the contained area drainage ditch. Water in the open section of the containment ditch on the West site boundary had suspended fines within it. Water from the containment ditch is to be tankered off site for disposal.

It was reported that the groundwater monitoring borehole on the North boundary was being redrilled as the groundwater monitoring pipe work had snapped when the well casing was withdrawn.

Work was being undertaken on the exploration borehole. This was reported to be installation of a sealing clamp.

No exploration well testing activities were taking place on site.

Materials, wastes, temporary buildings and equipment present on site were inspected.

Advisory:

The yellow mobile fuel bowser for the drilling rig has a direct drainage outlet in its bund with a removable threaded insert. The drainage outlet means the bowser does not meet the requirements of the Control of Pollution (Oil storage) (England) Regulations 2001. As the bowser is located on the HDPE containment area this has not been scored as a non-compliance. A loss of fuel from the bowser could result in contamination of the aggregate surface and containment ditch.
